1. These By-laws may be cited as the Contractors Registration (Amendment) By-Laws, 2009 and shall be read as one with the Contractors Registration By-Laws, hereinafter referred to as the "principal By-laws".

2. These By-laws shall come into operation on the date published in the *Gazette*.

3. The principal By-laws is amended:-

(a) in By-laws 6 by deleting sub-By-law (1) and substituting for it the following:-

"(1) An officer of the Board shall visit and inspect the offices, workshops, yards, properties and projects executed or any other facilities."

(b) in By-laws 7 by deleting sub-By-laws (2) and substituting for it the following:-

"(2) Specialist Contractors include those engaged in the following trades, namely-

(A) SPECIALIST RELATED TO CIVIL WORKS CONTRACTORS.

S/N	Name of Specialist Contractor	Basic Works
1.	Marine Works	Dredging works, land reclamation civil engineering works, heavy lifting, assembling and dismantling of marine parts, wreck removal, environmental projects, offshore oil and gas exploration, works related to offshore and under water construction.
2.	Tunnelling and underpinning	Tunneling and underpinning works including excavation, grouting, soil stabilization, road, railway and mining activities.
3.	Irrigation and flood control system	Construction of water retaining structure such as dams, reservoir, aqueducts, canals, dredging in canal, river and pipe laying works.
4.	Railway Tracks	New track construction, track renewal, track repair and maintenance, track and turnout undercutting, rail grinding, tie plugging, spot surface and tie replacement, change out broken/defective rails, recondition turnouts, switch points and frogs by welding etc.
5.	Landscaping and Slope Protection System, hard and soft landscaping	Application of erosion control products, concrete treatment system, and cellular confinement systems for slope protection, growing of vegetation, stockpiling of sand bags, plastic sheets, gabion baskets and rock fall netting. Surface treatments including cement grouts, polymeric, asphalt, sprayed seed emulsion coatings.
6.	Treatment plants and Water works	Installation and maintenance of water and waste treatment facilities. Solid waste treatment, sewerage and water systems installation and related works.
7.	Piling	Installation of all types of piling-sheet, driven pre-cast reinforced and pre-stressed concrete piles, bored cast-in-situ piles.
8.	Drilling works	Drilling works involves making holes using drills and rigs for the purpose of extraction of water, oil, gas, mineral samples etc or making allowance for construction activities.

9.	Concrete treatment and repair	Reinforcement of structures by way of pressure grouting, guniting, etc.

11.	Paving	Installation of paving blocks or tiles in internal/ external works.
12.	Mining	Blasting, excavation, hauling and mining operations.

1.	Interior decoration	This includes painting, installation of ceiling panels, partitions and built-in fittings, raised floor works. Bathroom and kitchen remodeling, cabinetry and built-ins, insulation, paneling and molding, etc
2.	Water proofing installation	Waterproofing of basement, roofs and walls.
3.	Carpentry and joinery works	Supplying and fixing all the materials in connection to carpentry and joinery works including all necessary.
4.	Demolition	Demolish the earmarked parts of existing structure, remove the debris from site and make good the other areas affected during demolition etc.

(c) in By-Laws 8 by-

- (i) deleting sub-By-Laws (1) and substituting for it the following—

"(1) The class limit for any single contract by a contractor shall be set out in Table 1 of the First Schedule".

- (ii) deleting the phrase "Second Schedule" wherever it appears and substituting for it the following phrase "First Schedule".

- (iii) deleting sub-By-laws (3) and substituting for it the following—

"(3) In determining the value of works to be executed for the purposes of ascertaining the class limit, costs of materials labour and other resources deployed for the execution of works shall be reckoned".

- (iv) Inserting immediately after sub-By-laws (3) the following proviso:

"Provided that the Board in its own discretion may direct or set restriction on the appropriateness of the class limit depending on the nature, magnitude and complexity of the project".

- (d) in By-laws 9, 10, 11, 12, 13, 14, 15 and 16 by deleting the phrase "Second Schedule" wherever it appears and substituting for it the phrase "First Schedule"

- (e) in By-laws 18, by deleting sub-By-laws (3) and substituting for it the following—

"(3) The fees payable under paragraph (1) are set out in Tables 9 and 10 of the second schedule and as may be reviewed by the Board from time to time".
