



CONTRACTORS REGISTRATION BOARD

Compliance on Construction Site.



The Contractors Registration Board (CRB) is a government institution that was established by the Contractors Registration Act CAP R.E 2002. It is charged with responsibility for registration, regulation and development of contractors.

Regulation in this context involves in ensuring that only registered contractors are allowed to carry out construction works and that the contractors comply with all governing regulations and laws of the country. The main objective of carrying out these functions is to protect the public in terms of delivery of the contractor's works and safety of both people and property for sustainable development .

Members of the public are hereby requested to report to the Board through the e-mail address and/ or telephone numbers listed at the bottom of any improper arrangements which contravene with construction regulations which may include the following:

1. A construction site without a Publicly displayed project signboard and/ or absence of a registered contractor(s) of the relevant type of works.
2. A construction site having workers not equipped with appropriate personal protective equipment (PPE's) like helmets, boots, overall, gloves, dust masks, google, safety belts depending on nature of the works.
3. A construction site which is not well sealed off such that hoarding, netting and/ or fencing is not adequately provided.
4. Absence of appropriate road signs and directives to traffic and other users of the road under construction.
5. A building construction site in which the contractor appearing on the signboard practically is not carrying out the works.
6. Any construction site which pose a threat to loss of life and/or property damage.
7. The construction site that is not fully equipped to deal with fire accidents as well as the absence or non - provision of appropriate hygienic facilities (toilet, wash basin etc).
