



TAARIFA KWA UMMA

MSAMAHA WA ADA YA UWASILISHAJI WA NYARAKA ZA KAMPUNI ZILIZOSAJILIWA KABLA YA MWAKA 2018

Msajili wa Kampuni anapenda kuwafahamisha Wadau na Umma kwa ujumla kuwa Waziri wa Viwanda na Biashara ametoa Notisi ya Msamaha wa asilimia hamsini (50%) ya ada ya uwasilishaji wa nyaraka za kampuni nje ya muda iliyotolewa katika Tangazo la Serikali Na. 410 la tarehe 24 Mei, 2024 na itatumika kwa kipindi cha miezi kumi na mbili tangu kuchapishwa kwake.

Waziri ametoa Notisi hiyo kwa kuzingatia kifungu cha 452A cha Sheria ya Kampuni, Sura ya 212 kinachotoa Mamlaka kwa Waziri mwenye dhamana ya masuala ya biashara kutoa msamaha wa ulipaji wa ada ya uwasilishaji wa nyaraka za kampuni nje ya muda. Notisi hii imetolewa kwa lengo la kuwezesha uhuishaji wa taarifa za kampuni zilizosajiliwa kabla ya mwaka 2018 kwenye mfumo wa Usajili kwa njia ya Mtandaoni (Online Registration System)

Kufuatia notisi hiyo, Msajili wa Kampuni anawataarifu kuwa msamaha wa asilimia hamsini (50%) unatolewa kwa ada ya ucheleweshaji wa nyaraka (late filing fee) kwa Kampuni zenye sifa zifuatazo;

- a) Kampuni zilizosajiliwa kabla ya mwaka 2018 ambazo taarifa zake hazijahuishwa kwenye Mfumo wa Usajili wa Kampuni kwa njia ya Mtandao,
- b) Maombi ya kuhuisha taarifa za kampuni yaliyopo kwenye Mfumo wa usajili wa kampuni kwa njia ya Mtandao kabla ya tarehe ya kuchapishwa kwa Notisi hii,
- c) Maombi ya kuhuisha taarifa za kampuni kwenye Mfumo wa Usajili wa Kampuni kwa njia ya Mtandao yatakayopokelewa kwenye Mtandao ndani ya muda wa Notisi hii,

Aidha, ifahamike kwamba maombi yaliyokwisha wasilishwa kwenye Mfumo na kupitishwa na Msajili au Msajili kuingia makubaliano yoyote na Kampuni husika ya jinsi ya kufanya malipo husika kabla ya tarehe ya Notisi hayatahusika na msamaha huu.

Msajili anazielekeza Kampuni zote zinazohusika na Msamaha huu kuwasilisha taarifa zao kwa Msajili kupitia mfumo wa ORS ndani ya muda ulioelekezwa ili kunufaika na msamaha huo.

WAIVER NOTICE OF THE LATE FILING FEE FOR COMPANIES REGISTERED BEFORE YEAR 2018

The Registrar of Companies is delighted to inform the general Public that the Minister for Industry and Trade has issued a 50% Waiver Notice of the late filing fee. The twelve-month Waiver Notice was published vide Government Notice dated 24th May, 2024.

The Waiver Notice is issued pursuant to section 452A of the Companies Act Cap 212 which empowers the Minister Responsible for Trade in consultation with the Minister responsible for Finance to Waive late filing fee by Notice published in the Gazette. The waiver extends to all companies Registered before 2018 prior the commencement of the Online Registration System (ORS) to enable them update their information onto the system.

Clause 4 (a) – (d) of the Notice entails the qualification for 50% waiver as follows;

- a) All Companies registered before the year 2018 whose information has not been updated onto the Online Registration System (ORS),
- b) All applications for update submitted through ORS and pending in the system prior to Publication of the Waiver Notice,
- c) All Applications for update which will be submitted through ORS within the amnesty period

It is to be noted that, the Waiver shall NOT in any way extend to any applicant who, prior publication of the notice, had paid in full or partly, or had made payment arrangement in agreement with the Office of Registrar for settlement of such late filing fees.

The Registrar of Companies call upon all companies intended by this notice to benefit from this waiver by updating their companies during the amnesty period.
